- Pricing is based on approx. 0.125% of your property's value, but ultimately, it's up to you
- Payment is due anytime up to 1 day before your scheduled clearing

Once your session is complete, I'll send follow-up notes and guidance to help you maintain a clear and peaceful space.

FAQ Highlights:

What happens during a clearing?

I intuitively scan your property, locate issues, and remove any entities or unwanted energies. I double-check my work to ensure nothing is missed. I don't engage with the energy—I simply clear it.

Is this done remotely?

Yes. Most clearings are remote and just as effective. In-person sessions (within 75 miles) are available but cost more and are harder to schedule.

Do I need to be home?

No. You can go about your day as usual. Some clients feel something during the clearing, but most don't notice anything until after.

Will I receive feedback?

Yes. You'll get a report on what I encountered and what was done. I don't attempt to "identify" specific entities—I focus on removal and resolution.



What if nothing changes?

This is rare, but if needed, I'll recheck and clear again. If there's still no improvement, I'll offer a refund. Your peace of mind matters.

Are there limits to what you can do?

Yes. If I feel something is beyond my ability, I'll let you know and refund you. Some places—like those built on major energetic disturbances—may be beyond the scope of this work.
